## Scope of Study

- ► Staff examined intentional homicides that occurred in Virginia between 2017 and 2022, including:
  - Nature and circumstances;
  - Victim and offender demographics;
  - Charges filed and case dispositions; and,
  - Criminal history records of convicted offenders.
- ► Intentional homicide included completed acts of capital/aggravated murder, first and second degree murder, felony murder, and voluntary manslaughter.
  - Did <u>not</u> include attempts, conspiracies, or solicitation.

#### Increases in Intentional Homicides

- ▶ Virginia experienced a *significant* increase in intentional homicides between 2017 and 2022.
- ► Virginia is consistent with the rest of the United States in terms of:
  - increases in homicides;
  - firearm use in homicides;
  - location of homicides;
  - demographics of homicide victims and offenders; and,
  - criminal history records of convicted homicide offenders.






#### Factors Contributing to Homicide Increases

- ► COVID-19 pandemic
- ► Individuals feeling "disrespected" (in-person and online)
- ► Gang and group disputes (territory, retaliation, etc.)
- ► "Ferguson effect" (decrease in proactive policing)
- ► Access to firearms and firearm thefts
- ▶ Drugs, drug sales, and drug markets (in-person and online)
- ▶ Mental health challenges and lack of treatment resources
- ▶ Domestic violence incidents
- ► Increase in police-community tensions
- ▶ Decrease in perceptions of police legitimacy

#### Location of Intentional Homicides

► The vast majority occurred in Virginia's metro/urban areas, with 57% in 10 localities.

# Victim-Offender Relationships

- ► The known relationships between the victim(s) and offender(s) in Virginia remained similar.
  - Almost half of relationships are unknown or missing.

## Victim Demographics

- ▶ 3,031 individuals were victims of intentional homicide:
  - 76% were male.
  - 50% were between ages 18 and 34.
  - 64% were Black individuals.
    - 33% were White individuals.
    - 3% were individuals of other races.

## Offender Demographics

- ▶ 3,060 individuals were charged with intentional homicide:
  - 870 individuals were convicted of intentional homicide:\*
    - 90% were male.
    - 68% were between ages 18 and 35.
    - 60% were Black individuals; 39% were White individuals.
  - 2,190 individuals were not convicted of intentional homicide or the charges were still pending as of May 2023:
    - 87% were male.
    - 73% were between ages 18 and 35.
    - 65% were Black individuals; 34% were White individuals.

#### **Intentional Homicide Charge Dispositions**

- ▶ Of the 3,060 individuals charged:
  - 28% (870) were convicted of intentional homicide;\*
  - 27% (826) were nolle prosequi;
  - 25% (773) were still pending as of May 2023;
  - 13% (405) were convicted of a different offense;
  - 3% (93) were dismissed;
  - 3% (81) were found not guilty; and,
  - <1% (12) were other disposition.</p>

## Racial Disparities

- ▶ Black males were disproportionally overrepresented as *both* victims and offenders of intentional homicide.
  - Black males comprise 9% of Virginia's overall population.
    - The population of Black males in Virginia's metro/urban areas ranged from 5% to 38% of that locality's overall population.
- ▶ 64% of intentional homicide victims were Black males.
  - The 2021 Virginia homicide victimization rate for Black males was 11.5 times higher than that of White males (OCME).
- ▶ 65% of individuals charged with and 60% of individuals convicted of intentional homicide were Black males.

### Criminal History Record Review

- ▶ 930 adults were convicted of an intentional homicide that occurred between 2017 and 2022 ("adult cohort").\*
  - 69% were convicted of first or second degree murder.
- ▶ 71% (656 of 930) of the adult cohort had a prior in-state criminal history record.
  - Criminal history records (CHR) varied significantly.




## **Prior In-State Criminal Charges**




# Criminal History Record Review

- ▶ Of the 656 adults with a prior in-state CHR:
  - 5% (32 of 656) had at least one prior in-state violent felony conviction per Va. Code § 19.2-297.1.
  - 67% (438 of 656) were sentenced to at least one prior term of active incarceration.

# Pending Charges

- ▶ 19% (176 of 930) of the adult cohort had *at least* one pending charge at the time of the intentional homicide.
  - <u>Felony</u> most common offense types: narcotics, larceny, and assault.
  - <u>Misdemeanor</u> most common offense types: assault, weapon, and contempt.

## **Supervision Status**

- ▶ **Pretrial services agency supervision:** 6% (53 of 930) of the adult cohort at the time of the homicide.
  - Most common offenses: narcotics, assault, and weapon.
- ► Local community corrections supervision: 3% (30 of 930) of the adult cohort at the time of the homicide.
  - Most common offenses: assault, narcotics, and larceny.
- ➤ **State supervision (DOC):** 18% (168 of 930) of the adult cohort at the time of the homicide.
  - Nearly 60% were on medium level supervision.
  - Most common offenses: larceny, narcotics, weapon, and assault.

#### **Protective Orders**

- ▶ 14% (133 of 930) of the adult cohort were subject to a protective order that was issued between 2017 and 2022 before the intentional homicide.
  - 29 of 133 adults were subject to a protective order at the time of the homicide.
    - 6 of 29 adults killed the named petitioner.
    - The victim-offender relationships were grandmother, mother, father, estranged wife, girlfriend, and 2 year old son.

#### **Community-Based Violence Intervention**

- ► Intentional homicide is a serious public health and criminal justice concern.
- ► The General Assembly recently allocated \$30 million for community-based violence intervention and the Safer Communities Program in Virginia.
- ► The Crime Commission will receive quarterly reports from DCJS on these intervention efforts.
