A charge with a disposition of “deferred” is not counted as a pending charge under this definition.

¹ The Public Safety Assessment tool was applied retroactively to create a uniform measure of risk of failure to appear and new criminal activity to be used for comparison purposes across all defendants in the cohort. Staff adhered and complied with the Public Safety Assessment Core Requirements and the Public Safety Assessment Scoring Manual when calculating proxy risk levels for FTA and NCA. The tool was not administered on any of the defendants in the cohort at the time of their October 2017 contact event. Virginia utilized a different pre-trial risk assessment tool (Virginia Pretrial Risk Assessment Instrument) at the time of the October 2017 contact events for defendants who met certain eligibility requirements.
