

§ 46.2-882.1. Use of photo speed monitoring devices in highway work zones, school crossing zones, and high-risk intersection segments; civil penalty

A. For the purposes of this section:

"High-risk intersection segment" means any highway or portion thereof located not more than 1,000 feet from the limits of the property of a school that is part of or adjacent to an intersection containing a marked crosswalk that is identified in the manner provided in this section as one in which a traffic fatality has occurred since January 1, 2014.

"Highway work zone" has the same meaning ascribed to it in § [46.2-878.1](#).

"Photo speed monitoring device" means equipment that uses radar or LIDAR-based speed detection and produces one or more photographs, microphotographs, videotapes, or other recorded images of vehicles.

"Retired sworn law-enforcement officer" means any officer of the United States, or of a state or political subdivision thereof, who was empowered by law to conduct investigations and make arrests and any attorney authorized by law to prosecute or participate in the prosecution of such offenses, who at the time of retirement kept an up-to-date certification and retired honorably in good standing. A retired sworn law-enforcement officer shall not be required to keep an up-to-date certification after the date of his retirement.

"School crossing zone" has the same meaning ascribed to it in § [46.2-873](#).

"Vehicle speed violation" means a violation of this title resulting from the operation of a vehicle in excess of the speed limit, including a violation of § [46.2-873](#) or [46.2-878.1](#).

B. A state or local law-enforcement agency may place and operate a photo speed monitoring device in school crossing zones for the purposes of recording violations of § [46.2-873](#) and in highway work zones for the purposes of recording violations of § [46.2-878.1](#).

A state or local law-enforcement agency may place and operate a photo speed monitoring device at a high-risk intersection segment located within the locality for the purpose of recording vehicle speed violations, provided that such law-enforcement agency certifies that a traffic fatality has occurred since January 1, 2014, in such segment.

C. The operator of a vehicle shall be liable for a monetary civil penalty imposed pursuant to this section if such vehicle is found, as evidenced by information obtained from a photo speed monitoring device, to be traveling at speeds of at least 10 miles per hour above the posted speed limit in the zone monitored by the photo speed monitoring device. Such civil penalty shall not exceed \$100, and any prosecution shall be instituted and conducted in the same manner as prosecution for traffic infractions. Civil penalties collected under this section resulting from a summons issued by a local law-enforcement officer or retired sworn law-enforcement officer

employed by a locality shall be paid to the locality in which such violation occurred. Civil penalties collected under this section resulting from a summons issued by a law-enforcement officer or retired sworn law-enforcement officer employed by the Department of State Police shall be paid into the Literary Fund. However, all civil penalties collected under this section resulting from a summons issued based on evidence obtained from a photo speed monitoring device placed and operated at a high-risk intersection segment shall be paid to the Commonwealth Transportation Board to be used for the Virginia Highway Safety Improvement Program established pursuant to § 33.2-373.

D. If a photo speed monitoring device is used, proof of a vehicle speed violation shall be evidenced by information obtained from such device. A certificate, or a facsimile thereof, sworn to or affirmed by a law-enforcement officer or a retired sworn law-enforcement officer, based upon inspection of photographs, microphotographs, videotapes, or other recorded images produced by a photo speed monitoring device, shall be prima facie evidence of the facts contained therein. However, for any photo speed monitoring device placed in a school crossing zone, such sworn certificate or facsimile thereof shall not be prima facie evidence of the facts contained therein unless such photographs, microphotographs, videotapes, or other recorded images, or documentation, depict or confirm a portable sign or tilt-over sign that is in position or blinking sign that is activated, indicating the school crossing zone pursuant to § 46.2-873, at the time of such vehicle speed violation. Any photographs, microphotographs, videotapes, or other recorded images evidencing such a violation shall be available for inspection in any proceeding to adjudicate the liability for such vehicle speed violation.

E. In the prosecution for a vehicle speed violation in which a summons was issued by mail, prima facie evidence that the vehicle described in the summons issued pursuant to this section was operated in a manner constituting a vehicle speed violation, together with proof that the defendant was at the time of such violation the owner, lessee, or renter of the vehicle, shall constitute in evidence a rebuttable presumption that such owner, lessee, or renter of the vehicle was the person who committed the violation. Such presumption shall be rebutted if the owner, lessee, or renter of the vehicle (i) files an affidavit by regular mail with the clerk of the general district court that he was not the operator of the vehicle at the time of the alleged violation and provides the name and address of the person who was operating the vehicle at the time of the alleged violation or (ii) testifies in open court under oath that he was not the operator of the vehicle at the time of the alleged violation and provides the name and address of the person who was operating the vehicle at the time of the alleged violation. Such presumption shall also be rebutted if a certified copy of a police report, showing that the vehicle had been reported to the police as stolen prior to the time of the alleged vehicle speed violation, is presented, prior to the return date established on the summons issued pursuant to this section, to the court adjudicating the alleged violation.

F. Imposition of a penalty pursuant to this section by mailing a summons shall not be deemed a conviction as an operator and shall not be made part of the operating record of the person upon whom such liability is imposed, nor shall it be used for insurance purposes in the provision of motor vehicle insurance coverage. However, if a law-enforcement officer uses a photo speed monitoring device to record a vehicle speed violation and personally issues a summons at the time of the violation, the conviction that results shall be made a part of such driver's driving record and used for insurance purposes in the provision of motor vehicle insurance coverage.

G. A summons for a vehicle speed violation issued by mail pursuant to this section may be

executed pursuant to § 19.2-76.2. Notwithstanding the provisions of § 19.2-76, a summons issued by mail pursuant to this section may be executed by mailing by first-class mail a copy thereof to the owner, lessee, or renter of the vehicle. In the case of a vehicle owner, the copy shall be mailed to the address contained in the records of or accessible to the Department. In the case of a vehicle lessee or renter, the copy shall be mailed to the address contained in the records of the lessor or renter. Every such mailing shall include, in addition to the summons, a notice of (i) the summoned person's ability to rebut the presumption that he was the operator of the vehicle at the time of the alleged violation through the filing of an affidavit as provided in subsection E and (ii) instructions for filing such affidavit, including the address to which the affidavit is to be sent. If the summoned person fails to appear on the date of return set out in the summons mailed pursuant to this section, the summons shall be executed in the manner set out in § 19.2-76.3. No proceedings for contempt or arrest of a person summoned by mailing shall be instituted for failure to appear on the return date of the summons. If the summons is issued to an owner, lessee, or renter of a vehicle with a registration outside the Commonwealth and such person fails to appear on the date of return set out in the summons mailed pursuant to this section, the summons will be eligible for all legal collections activities. Any summons executed for a vehicle speed violation issued pursuant to this section shall provide to the person summoned at least 30 days from the mailing of the summons to inspect information collected by a photo speed monitoring device in connection with the violation. If the law-enforcement agency that was operating the photo speed monitoring device does not execute a summons for a vehicle speed violation issued pursuant to this section within 30 days from the date of the violation, all information collected pertaining to that suspected violation shall be purged within 60 days from the date of the violation.

H. A private vendor may enter into an agreement with a law-enforcement agency to be compensated for providing a photo speed monitoring device and all related support services, including consulting, operations, and administration. However, only a law-enforcement officer or retired sworn law-enforcement officer may swear to or affirm the certificate required by this section. Any such agreement for compensation shall be based on the value of the goods and services provided, not on the number of violations paid or monetary penalties imposed. Any private vendor contracting with a law-enforcement agency pursuant to this section may enter into an agreement with the Department, in accordance with the provisions of subdivision B 31 of § 46.2-208, to obtain vehicle owner information regarding the registered owners of vehicles that committed a vehicle speed violation. Any such information provided to such private vendor shall be protected in a database.

I. Information collected by a photo speed monitoring device operated pursuant to this section shall be limited exclusively to that information that is necessary for the enforcement of vehicle speed violations. Information provided to the operator of a photo speed monitoring device shall be protected in a database and used only for enforcement of vehicle speed violations and enforcement against individuals who violate the provisions of this section. Notwithstanding any other provision of law, all photographs, microphotographs, videotapes, or other recorded images collected by a photo speed monitoring device shall be used exclusively for enforcing vehicle speed violations and shall not be (i) open to the public; (ii) sold or used for sales, solicitation, or marketing purposes; (iii) disclosed to any other entity except as may be necessary for the enforcement of a vehicle speed violation or to a vehicle owner or operator as part of a challenge to the violation; or (iv) used in a court in a pending action or proceeding unless the action or proceeding relates to a vehicle speed violation or a violation of this section, or such information

is requested upon order from a court of competent jurisdiction. Information collected under this section pertaining to a specific violation shall be purged and not retained later than 60 days after the collection of any civil penalties. Any law-enforcement agency using photo speed monitoring devices shall annually certify compliance with this section and make all records pertaining to such system available for inspection and audit by the Commissioner of Highways or the Commissioner of the Department of Motor Vehicles or his designee. Any person who discloses personal information in violation of the provisions of this subsection shall be subject to a civil penalty of \$1,000 per disclosure.

J. A conspicuous sign shall be placed within 1,000 feet of any school crossing zone, highway work zone, or high-risk intersection segment at which a photo speed monitoring device is used, indicating the use of the device. There shall be a rebuttable presumption that such sign was in place at the time of the commission of the speed limit violation.

K. Any state or local law-enforcement agency that places and operates a photo speed monitoring device pursuant to the provisions of this section shall report to the Department of State Police, in a format to be determined by the Department of State Police, by January 15 of each year on the number of traffic violations prosecuted, the number of successful prosecutions, and the total amount of monetary civil penalties collected. The Department of State Police shall aggregate such information and report it to the General Assembly by February 15 of each year.

Brief: Recommendations to Promote Equity in Speed Safety Camera Programs

The full report, [Fair Warnings: Recommendations to Promote Equity in Speed Safety Camera Programs](#), shares actions to help communities address equity concerns about speed safety cameras.

About This Effort

These recommendations aim to help communities using speed safety cameras to do so effectively and equitably. The equity impacts of speed safety camera programs have been only sparsely assessed, and the findings are often unclear and sometimes contested. To help fill this gap in understanding, in 2024 Vision Zero Network led a group of public safety partners from different sectors — including researchers, criminal justice leaders, road safety practitioners and advocates — to develop these recommendations.

Summary of Recommendations

High speeds are a leading contributor to preventable traffic deaths and injuries. Speed safety cameras, when used appropriately, can deter dangerous speeds and help prevent traffic deaths and injuries. They also offer benefits over police-led traffic stops for speeding.

At the same time, speed safety cameras still operate in a system saddled with structural inequities, causing concerns of exacerbating racial and income disparities. For example, neighborhoods with higher proportions of Black, Latino and low-income residents face greater exposure to high-speed, high-injury streets, where speed safety cameras are most likely to be justified. This, along with the regressive flat-fee traffic fine system that disproportionately impacts low-income people, may result in some facing significant financial and legal burdens for what could be considered “predictable mistakes” based on road design and land use factors.

For these and other reasons detailed in the report, speed safety cameras should not be the leading nor sole strategy communities use to manage unsafe speeds. Instead, they should be considered part of a holistic Safe System approach to prioritize proactive, upstream strategies, such as self-enforcing road designs that physically slow drivers, speed limiting technology in vehicles and other policies that do not over rely on punitive measures.

These recommendations draw from examples across the country and provide jurisdictions with specific actions to better recognize and address equity-related concerns of speed safety cameras. Taking a thoughtful, equity-centered approach to speed safety camera programs can help manage speeds and result in fewer serious crashes, injuries and deaths; more enduring improvements in road design and policies; fewer speeding tickets issued and — ultimately — less need for enforcement.

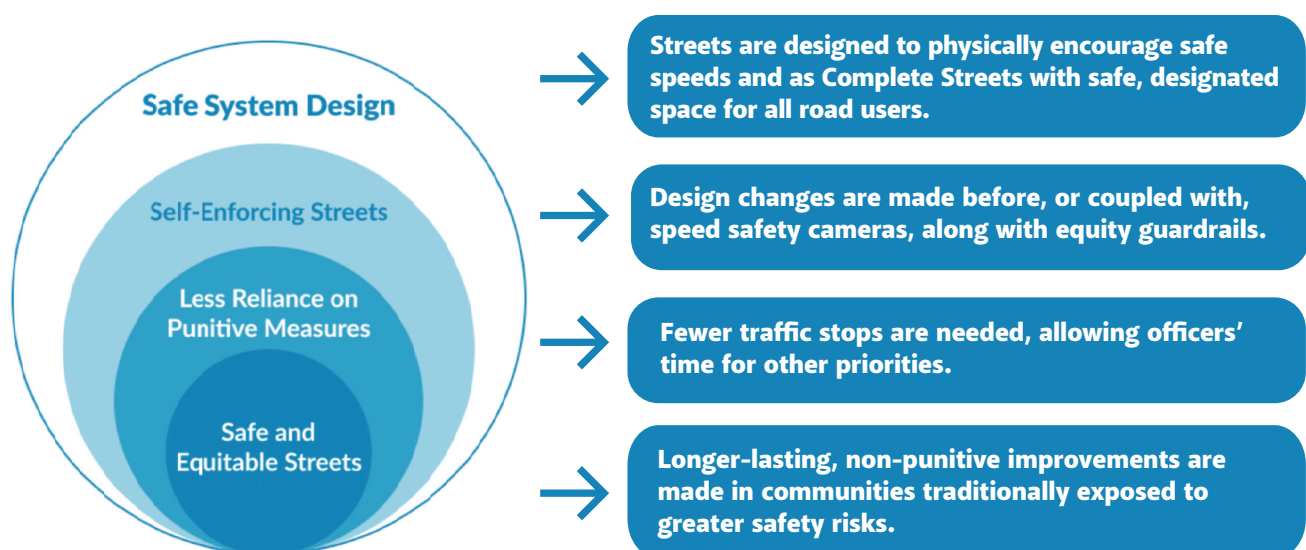
Consideration and Placement of Speed Safety Cameras

- Prioritize upstream, preventative safety measures along with, or in place of, speed safety cameras wherever possible. These include self-enforcing road designs, such as traffic calming to physically slow drivers; lowering speed limits and increasing speed limit signage density; and adding speed limiting features in vehicles, such as Intelligent Speed Assistance (ISA).
- Place cameras using a transparent, equity-centered process and a systemic safety analysis that screens an entire network for high-risk areas, then addresses them comprehensively rather than a piecemeal, reactive approach.
- Incorporate community members' input, especially those living and moving in the neighborhoods most affected by high speeds and historically underrepresented groups.
- Place cameras based on safety needs that are not limited by jurisdictional issues (ex: state-owned roads) or specific "use zones" (school zones).



Financial Considerations

- Restrict fines to reasonable amounts that are the lowest possible to influence behavior change. In a regressive fine system, wealthier individuals can continue speeding by paying fines, while those with limited finances face disproportionate burdens that can unduly entangle them in the legal system. Lower fines can also improve public perception of the program, contributing to its effectiveness.
- Begin with warning periods to help people become aware and adjust their behaviors.
- Offer alternatives to financial penalties, reduced payments or partial payments over time to align with people's ability to pay, as many newer speed safety camera programs are doing.
- Refrain from adding unrelated fees and surcharges to tickets and from using criminal penalties and disproportionate sanctions, such as license suspensions, for the inability to pay.
- Address repeat speeding with more effective and equitable strategies, such as requiring Intelligent Speed Assistance (ISA) systems, which alert drivers when they exceed posted limits, in the vehicles of repeat speeding offenders.



When we design streets that create space for different types of road users and with built-in safety countermeasures, we get streets that are inherently self-enforcing – reducing the need for officer initiated enforcement.

Use of Funds Generated

- The goal of speed safety cameras is deterring dangerous speeds through consistent and predictable enforcement — not to generate revenue. This should be emphasized in the design, operations and communications of programs.
- Any revenue generated from these programs (beyond administrative costs) should be directed to roadway safety projects — ideally those where cameras have been deemed as needed — and not to a jurisdiction's general fund or other expenses. Communities should not become overly reliant on camera revenue to fund basic government operations.
- Similarly, steps should be taken to ensure that critical street safety treatments do not become dependent on punitive measures, such as camera ticket revenue.



Program Expenses

- Establish clear rules for vendors working on camera programs to ensure equity and transparency in administering them. For example, contracts should not charge on a per-ticket basis, which could incentivize revenue generation over safety and equity goals.
- House speed safety camera programs in transportation or public works departments, rather than law enforcement agencies, to better align with road safety goals and cultivate community trust.
- Create surveillance and data protections about what is recorded, where data is stored, who has access to data and how it can be used.



Monitoring and Evaluation

- Develop and use safety metrics to assess the effectiveness of the program overall and at individual camera locations. And ensure flexibility to address problems and relocate cameras when they are not effective in improving safety.
- Develop and use metrics and thresholds to assess equity impacts and monitor the program for potential disproportionate racial or equity impacts. This should include, when possible, data on the vehicles receiving violations, demographics of those vehicle owners, amounts of fines and fees, citation and collections rates, among others.
- Monitor and communicate about what upstream safety strategies are being implemented or considered at the locations identified for speed cameras, such as road redesigns, traffic calming measures and other nonpunitive measures.

Note that these recommendations are not intended to address all aspects of speed safety camera usage but rather focus on equity-specific considerations. Also, while other types of automated enforcement programs may benefit from these considerations, these recommendations were developed specifically to address dangerous speeds as a leading cause of severe traffic injuries and deaths.



AUTOMATED ENFORCEMENT PROGRAM CHECKLIST

For red light cameras and
automated speed enforcement

Automated enforcement is an effective tool to make roads safer. Research shows that red light cameras reduce violations and injury crashes, especially the violent front-into-side crashes most associated with red light running. Speed cameras have been shown to reduce vehicle speeds, crashes, injuries and fatalities. Both types of programs should be designed, implemented and administered properly. Poorly run programs are less likely to be durable and may undermine support for automated enforcement generally.

Speed and red light camera programs augment traditional enforcement to improve traffic safety by deterring dangerous driving behaviors. Automated enforcement does not require traffic stops, and well-designed programs can improve safety for all road users in a neutral manner.

Successful programs are transparent and have a strong public information component. Communities should take into account racial and economic equity when making decisions about camera placement and fines. Automated enforcement programs should be data-driven and should prioritize safety, not revenue. In fact, communities should expect that revenue will decline over time as fewer drivers run red lights or violate speed limits.

This checklist assumes your community is already legally authorized to set up a program. It provides a minimum list of considerations to help you follow best practices. The goal is to operate a successful program that reduces crashes and prevents deaths and injuries while maintaining strong public support. Automated enforcement can be integrated into broader efforts to discourage unsafe driving that include optimizing speed limits for safety and improving roadway design.

FIRST STEPS

- ☐ Identify problem intersections and roadways.
 - Assess violation and crash data.
 - Conduct field observations.
 - Collect resident and roadway user input.
- ☐ Consider what role automated enforcement should play as part of a comprehensive traffic safety strategy.
- ☐ Make any engineering or signage changes needed to improve drivers' compliance with the law.
 - Ensure the road geometry conforms with guidelines from the American Association of State Highway and Transportation Officials, National Association of City Transportation Officials guidance or state road design manuals, as appropriate.
 - Remove sightline obstructions of signals and signage.

For red light cameras:

- Ensure that yellow light timing conforms to the Manual on Uniform Traffic Control Devices and Institute of Transportation Engineers guidelines.

For automated speed enforcement:

- Ensure the speed limit is appropriate and accounts for all road users. Follow guidance and use tools from the Federal Highway Administration, Institute of Transportation Engineers, and the National Association of City Transportation Officials.
 - Ensure the speed limit is appropriate for special conditions, such as work zones and school zones.
 - Assess whether engineering changes could be made to promote compliance with the speed limit.
 - Ensure adequate posting of speed limits.
- ☐ Establish an advisory committee comprised of stakeholders.
 - Consider including law enforcement, transportation department employees, victim advocates, equity and civil rights advocates, school officials, community residents, first responders, health officials and the courts.
 - Outline the committee's role. This may include developing guiding principles related to safety, equity, and transparency, as well as other aspects of the program.
 - Ensure committee meetings are open to the public and deliberations are transparent.
 - ☐ Meet with the media, including newspaper editorial boards, to build support and educate the public.





SECOND STEPS

- ☐ Make program design decisions, consulting with the advisory committee as appropriate.

Program design considerations

Target violations with the greatest safety consequences. For example, you might decide not to ticket for right-turn-on-red violations when pedestrians, bicyclists, and oncoming vehicles are not present or to limit violations in work zones to when workers are present, provided the road configuration has not also been altered for construction.

Establish a reasonable fine structure. Create options for indigent violators such as payment plans or other alternatives.

Establish a threshold that must be crossed before a vehicle is photographed for a violation of red light running or speeding (i.e., a period after a light turns red or a certain mph over the posted speed). The point is to target flagrant, rather than marginal, infractions.

Programs should include a process for evidence review by appropriately trained personnel to determine if a violation occurred and issue a citation if warranted.

Establish clear procedures for contesting an alleged violation. Consider options to contest online or by mail.

When possible, red light camera violations should be recorded in real time video, and videos of the offense should be made available to the vehicle owner for review via the Internet.

Fines in excess of program costs should be allocated to transportation safety programs.

- ☐ Use safety data gathered in the first steps to determine camera locations, ensuring that particular neighborhoods are neither overlooked nor overrepresented.
- ☐ Publicize the extent of the safety problem and the need for innovative solutions.
- ☐ Secure a vendor and establish payment based on the vendor's actual costs, not the number of citations.
- ☐ Publicize procedures for contesting an alleged violation.
- ☐ Create a website and social media plan to publicize program details, such as how to pay and dispute tickets. Establish a method for answering questions accurately and in a timely manner.
- ☐ Develop an emergency action plan for handling problems, such as system malfunctions.



IMPLEMENTATION

- ☐ Hold a kickoff event with advisory committee members. Introduce a well-developed and sustained public education campaign focused on improving safety by changing driver attitudes and behavior.
- ☐ Connect the program to overall roadway safety in the community and identify the goal of zero tickets resulting from changes in driver behaviors.
- ☐ Install prominent warning signs.
- ☐ Start with a probationary period during which only warnings are issued.
- ☐ Follow current guidance from the U.S. Department of Transportation for implementation and operation of automated enforcement devices.
- ☐ Allow for due process. Minimize the number of days between the violation and citation issuance.



LONG TERM

- ☐ Publicize changes, including new camera locations. Reinstate the probationary period before ticketing begins at new locations.
- ☐ Monitor program operation and publicize results. Undertake periodic reviews and ensure racial, economic and other equity issues and public concerns are addressed.
- ☐ Require regular field reviews. Verify monthly camera calibration and synchronization with signals.
- ☐ Require regular evaluations of the traffic safety benefits of the program by collecting crash and infraction data. Before-and-after comparisons must use control intersections and roadways. Include control intersections and roadways that are not subject to spillover effects.
- ☐ Regularly meet with the advisory committee and media to review program status and sustain public support.
- ☐ Continue to improve programs based on new and updated guidance and best practices and look for opportunities to expand automated enforcement use.
- ☐ Consider other changes, including roadway design improvements, in order to reduce opportunities for unsafe driving.
