Rap Back – Success to Date

- Subscriptions Established: 4,802 (as of 08/13/2025) Rap Back subscriptions across participating agencies since the July 1st, 2025 launch.
- Rap Back Activity Notifications: 2 notifications triggered so far—both from new Disposition events.

Rap Back – Jurisdiction & Program Reach

Jurisdiction & Program Reach

- Jurisdiction: Statewide, serving all eligible government agencies in Virginia—including public and private K-12 schools, childcare providers, healthcare organizations, and eligible entities authorized to receive criminal history record information for positions of trust.
- Pricing (per enrolled individual):
 - Fingerprint-Based Background Check: \$27 (standard fee)
 - Rap Back Enrollment Fee: \$12 per individual, billed annually to participating agencies.
 - Renewal Fee: \$12 (if applicable, for continued monitoring after initial enrollment at the end of each subscription cycle which is one year).
 - Total: \$39

Rap Back Enhancements

Provide Rap Back Subscribers with enhanced subscription management capabilities through a Subscriber Portal.

- Comprehensive Subscription Dashboard:
 - Filter and view all active, pending, expired, and canceled subscriptions for your agency.
 - Search by name, Rap Back Subscription Identifier (RBSI), Transaction Control Number (TCN), and additional identifiers for quick access and management.
 - Summary dashboard delivers at-a-glance details: Name, Date of Birth, RBSI, TCN, Status, Subscription Date.
- **Self-Service Actions:**
 - Cancel subscriptions instantly as soon as eligibility ends thereby minimizing compliance risk.
 - Un-cancel/Reinstate subscriptions within a 60-day window to quickly correct any erroneous cancellations and ensure continuous coverage.

Seamless Billing, Payments, and Documentation for Subscribers

- Automated Subscription Payments
 - Make secure, convenient payments for renewals via direct OEBS customer portal integration—all renewals tracked in real time.
- One-Click Document Access
 - Download Privacy Act Statement templates ready for use at any stage of the hiring process.
 - Access and save up-to-date subscriber training materials to stay informed and compliant with the latest Rap Back requirements.
 - VSP is actively working to develop an online training module to fulfill subscribers' training and auditing requirements.
